Agenda Items:

1. Strategic Planning Session

- Discussion: Rhonda (Charlene's sister, experienced facilitator) is willing to facilitate
 the strategic planning session (cost \$1500 max; approx. \$75 per hour): Dave agrees
 cost is reasonable and Board consensus is we should go ahead with this. No motion
 needed. Charlene to contact Rhonda and send out email to Board, suggesting
 possible dates. Evenings? (one, or two if required)
- Preparation before meeting: Rhonda has bylaws, past strategic plan; Survey to be sent out to members (designed by Chelsea- simple, 6 questions), give results to Rhonda; Need to have Rhonda interview several key board members as well.
- Topics needed to be decided in conjunction with Rhonda; referring to old strategic plan and updates to it: identify results already achieved in old strategic plan

Tentative date: likely end of May.

Rate changes: if required by results of the strategic plan, must be approved by Rec Sites & Trails; Rate change is operational, not part of the strategic plan, which is more the vision and goals;

2. Ski Wax Proposal /Both selling wax and accessories and rental)

- Discussion: most clubs sell a couple of lines of hard wax, spray wax, corks etc; We should do this as well. How do we help support local businesses (rather than an online business)? May need products not available at local stores but avail online (skiwax.ca)? Need to contact local community businesses/partners re supply possibilities; what they can order.
 - Should we have waxes etc ?- an operational decision (Chelsea and team)
 - Need to educate most skiers re waxes

Discussion tabled: Chelsea has a plan for a next year re ski shop, waxing clinics etc. and can present it in the fall.

5a. Change of fiscal year – do we wish to and what period?

Email sent to our accountant Stone and Co. re change of fiscal year: OSC needs to send letter to CRA requesting change of year end;

• Discussion: like to change y/e to earlier: June, July or August? More appropriate then current y/e of September 30, then AGM will be about the actual just finished ski season and the corresponding financial year.
